Andaman & Nicobar Islands Right to Information Rules, 2005.

NOTIFICATION

Port Blair, dated the 24th November, 2005

No. 314/2005/F.No.1-252/2005/Tsm/RTIR-2005.—In exercise of powers conferred under section 28 of the Right to Information Act, 2005 (Act No.22 of 2005) read with section 2 (e)/(v) thereof, the Lt. Governor, A&N Islands hereby makes the following Rules namely :-

1. Short title and commencement:-

- (1) These rules may be called the **A&N Islands Right to Information (Regulation of fee and cost) Rules, 2005**
- (2) They shall come into force from the date of their publication in the Official Gazette.

2. Definitions :-

- (1) In these rules, unless the context otherwise requires:-
 - (a) 'Rules' means the Right to Information Rules, 2005.
 - (b) 'Authorized person' means a person nominated by the competent authority to accept fee prescribed under these rules;
 - (c) 'Section' means a section of the Act.
- (2) Words and expressions used but not defined in these rules shall have the meaning as assigned to them in the Act.

3. A request for obtaining information under sub-section (1) of section 6 shall be accompanied by an application fee of rupees 25/- by way of cash against proper receipt or by demand draft OR Bankers cheque payable to the Accounts Officer of the Public Authority.

4. For providing the information under sub section(1) of the section 7, the fee shall be charged by way of cash against proper receipt or by a demand draft or bankers cheque payable to the Accounts Officer of the public authority at the following rates-

- a. Rupees two for each page (in A-4 or A-3 size paper) created or copied.
- b. Actual charges or cost prize of a copy in large size paper.
- c. Actual cost or price for samples or models; and
- d. For inspection of records no fee for the first hour and a fee of rupees five for each fifteen minutes (or fraction thereof) thereafter;

5. For providing the information under sub section (5) of the section 7, the fee shall be charged by way of cash against proper receipt or by demand draft or bankers cheque payable to the Accounts Officer of the public authority at the following rates:-

- a. For information provided in diskette or floppy rupees fifty per diskette or floppy ; and
- b. For information provided in printed form, at the price fixed for such publication or rupees two per page of the photocopy for extracts from the publication.

No fee will be charged from the applicants under BPL category. However, the applicant seeking the information has to enclose a Xerox copy of the BPL certificate in support of his claim failing which application will be summarily rejected without giving any reason.

No. 9/2007/F.No. 3-38/2006-AR(PF-I).—In exercise of powers conferred under section 28 of the Right to Information Act, 2005 (Act No. 22 of 2005) read with section 2 (e)/(v) thereof, the Lt. Governor, Andaman & Nicobar Islands hereby makes the following amendment in the Notification No. 314/2005/F.No.1-252/2005/Tsm/RTI-2005 dated 24/11/2005 published in the Andaman & Nicobar Gazette No. 324 dated 24/11/2005, namely:-

1. Short Title and Commencement:-

(i) These rules may be called the Andaman and Nicobar Islands Right to Information (Regulation of fee and cost) (amendment) Rules, 2007.

(ii) They shall come into force from the date of their publication in the Official Gazette.

2. Rule 3 of the Andaman & Nicobar Islands Right to Information (Regulation of fee and cost) Rules, 2005 published vide Notification No. 314/2005/F.No. 1-252/2005/Tsm/RTI/2005 dated 24/11/2005 shall be substituted as under:-

“A request for obtaining information under sub-section (1) of section 6 shall be accompanied by an application fee of rupees 10/- by way of cash against proper receipt or by demand draft OR Bankers cheque payable to the Accounts Officer of the Public Authority”.
